The 2018 Grissom ARB JLUS is a cooperative planning effort conducted as a joint venture between Grissom Air Reserve Base (ARB); the counties of Miami, Howard, Cass, and Wabash; the cities of Peru, Kokomo, Logansport, Wabash, and Greentown; the towns of Bunker Hill, Onward, Converse, Galveston, Walton, and Denver; and other community stakeholders. The Miami County Economic Development Authority (MCEDA) will serve as the JLUS project sponsor and coordinating office.
